For two party contracts (Household discounted contracts) there is one \$3 reduction.
- * MEDICARE - BLUE SHIELD CA - The Household Discount is an additional 7% savings that will apply when the second member in your household enrolls in the same Blue Shield Medicare Supplement plan.
- * MEDICARE - BLUE SHIELD CA - The New to Medicare Discount is a \$25 per month rate reduction if you're new to Medicare Part B. To qualify, you must be 65 or older and Blue Shield must receive your application within 6 months of the date you first enrolled for benefits under Medicare Part B. The savings will be in effect for the first 12 months of your plan dues. Does not apply to Hi-Deductible F.
- * MEDICARE - CIGNA CA - Loyal American Life Insurance Company (a Cigna Company) There is a one-time \$20 Policy/Application Fee in addition to the insurance premium rate quoted.
- * MEDICARE - HEALTH NET CA - The New to Medicare Discount is a \$30 per month rate reduction if you're new to Medicare Part B. To qualify, you must be 65 or older and Health Net must receive your application within 6 months of the date you first enrolled for benefits under Medicare Part B. The savings will be in effect for the first 12 months of your plan dues.
- * MEDICARE - UNITED WORLD CA - The Household Discount is an additional 12% savings that may apply when the applicant is age 65 or older and a member in the household is age 60 or older.
- * MEDICARE – UNITEDHEALTHCARE CA - The Household Discount is an additional 5% savings that will apply when the second member in your household enrolls in an UnitedHealthcare Medicare Supplement plan.
- * MEDICARE – UNITEDHEALTHCARE CA - The rates shown on this quote applies to individuals whose plan effective date will be within ten years following their 65th birthday or, if later, the Medicare Part B effective date.
- * MEDICARE PLAN N - Plan N pays 100% of the Part B coinsurance, except for a copayment of up to \$20 for some office visits and up to a \$50 copayment for emergency room visits that don't result in an inpatient admission.
